





### **Learning outcomes**

- Students have to expose the theoretical arguments that justify why a member of academic community being is a moral being and its consequences in personal and professional life.

#### **Learning outcomes**

Students have to understand and consider the main constitutive elements of academic communities: moral dignity, laws, code of conducts; moral conscience, responsibility, duties and rights.

Students have been shown to be able to analyze critically the characteristics of the main ethical currents such as deontologism, utilitarianism, and consequentialism.

Students have consolidated their capacity to reflect and make decisions through the resolution of practical cases from ordinary life, applying the insights learned in ethics.






### **Activities**

- ➤ In person Lectures: aimed mainly to the acquisition of the skill of knowledge recognized in the Basic Competence, it prioritizes the transmission of knowledge by the lecturer, requiring the *student's interaction and discussion* and prior preparation.
- > STUDENT WORK (teamwork project) aims to acquire the skill of application of knowledge, as well as the ability to gather, interpret and judge relevant information and data.
- Role play: Training activity mainly aims to the acquisition of knowledge communication skills to react in a certain ethical situation.

### E & D Teaching Calendar 2023-2024







#### A GUIDELINE TO WRITE MINI- PROJECT ON ETHICS AND DEONTOLOGY TOPICS

#### INTRODUCTION

- State the topic related question/ theory you are trying to answer or explain.
- · State why the question is important
- State the issues problems involved
- State why we should be concerned with resolving them.
- State the implications and consequences of dealing with or resolving the issues involved.

#### DISCUSSION

- REVIEW OF THE LITERATURE: Summarize and synthesize research/studies that presents and deals with your topic.
- · State related real-life examples related to the topic under discussion.
- Sate any related codes of conduct, rules, (can be religious; legislative, administrative; social), related with your question/topic.
- State how and elaborate on how, explain how, illustrate sources you previously reviewed help you answer your topic related question.

#### CONCLUSIONS

- State the conclusions regarding your topic you have reached.
- · Indicate how codes of conduct, rules, have contributed to your conclusions
- State the implications and consequences of your conclusions
- State the social/academic significance these implications and consequences might have

#### DOCUMENTATION

- On a separate page, include a section labeled References which provides the full publication information for all the sources you used in your paper
- · You should have a MINIMUM of three (3) sources for your paper
- Not meeting this minimum requirement of three (3) sources will lead to a lower evaluation of your paper for each missing source
- Use APA format for documenting your sources
